




AFFIDAVIT OF JODY SMITH

I, Jody Smith of Stoney Creek, Ontario, MAKE OATH AND SAY:


1. I served David MacNeil with the Summons from Collingwood Judicial Inquiry by leaving a copy on September 30th, 2019, at 7:43pm with Ron MacNeil, who appeared to be an adult member of the same household in which David MacNeil is residing, at [REDACTED] Ontario, and by sending a copy by regular mail on October 1, 2019 to David MacNeil at the same address. A copy of the Summons and covering letter are attached as Exhibit "A".
2. I ascertained that the person was an adult member of the household by means of asking the man who answered the door if he was Ron MacNeil, and had a brother David MacNeil. The man answered yes. Ron MacNeil declined to accept the service and shut the door in my face.
