6.1 Paul Bonwick's Involvement in Further Acquisition Discussions

550. On January 24, 2012, Ed Houghton emailed John Glicksman, Dennis Nolan, Mark Henderson, Brian Bentz and Paul Bonwick asking to have a brainstorming session that week on the next steps for "growing" Collus. A meeting was scheduled for Dennis Nolan, John Glicksman, Ed Houghton and Paul Bonwick on January 26. Councillor Chadwick asked Mr. Bonwick how his meeting with PowerStream went and whether they were interested in any further work. Mr. Bonwick replied "Yes ... they want me to present a six month plan including monitoring from Provincial government. Please keep going until we chat."

552. On February 8, 2012, John Glicksman informed Paul Bonwick they were not going to proceed with the hospitality suite at the Electricity Distributor's Association conference and would instead take a low-key approach. Mr. Bonwick forwarded the email to Ed Houghton and suggested that they chat.

554. On February 13, 2012, Paul Bonwick asked if Brian Bentz was available on March 27, 2012 for lunch with Innisfil Hydro and dinner with Orangeville/Wellington Centre. On February 20, 2012, Paul Bonwick emailed Ed Houghton to ask him to confirm a March 27, 2012 breakfast meeting with Innisfil Hydro, a lunch meeting with Orangeville Hydro and Wellington Center, and perhaps a dinner with Westario. Mr. Bonwick also suggested, "a broader discussion related to the Drummond Report and how we might best use that information to instigate consolidation discussions with LDC's across the Province."

Mr. Houghton responded with suggested wording for the Mayor's comments.

556. An email chain containing a reporter's questions to Mayor Cooper about the Drummond Report was also forwarded to Paul Bonwick. One of the questions concerned whether the Drummond Report's recommendations would delay or hamper the Collus-PowerStream transaction. Mr. Bonwick responded to Ed Houghton, indicating:

No there is no concern that the Drummond Report would in any way negatively impact our initiative. In fact it clearly supports the initiative a being very progressive.

The only urgency attached to the deal comes in the form of the Town being paid 15 million dollars and the ability to move forward on our growth strategy recognizing the direction provided by the Drummond Report.

557. On March 25, 2012, Paul Bonwick emailed Brian Bentz suggesting that Mr. Bonwick not attend introductory meetings scheduled for the next day. Mr. Bonwick indicated that he and Mr. Houghton felt that it might appear somewhat presumptuous to have a consultant responsible for consolidation and expansion attend these meetings. Mr. Bentz, Mr. Bonwick, and Mr. Houghton had meetings scheduled with representatives from other LDCs on March 26. In the same email, Mr. Bonwick advised that he had put in a request to have a Minister make positive mention of the Collus PowerStream partnership in an upcoming speech.

558. On March 29, 2012, Paul Bonwick circulated an agenda for a March 30, 2012 meeting. The first agenda item was to "discuss presentation, strategy and recommendations for the meeting with the Premier's Office related to consolidation." The second agenda item was to discuss specific strategies for six LDCs. The following day, Ed Houghton sent an

amended version of the agenda to Paul Bonwick that identified key individuals at each of the relevant LDCs.

560. Around this time, Paul Bonwick also set up a meeting for April 3, 2012, to talk with John Herhalt and John Rockx about strategies pertaining to consolidation in the LDC sector. Mr. Rockx asked if the meeting would involve Mr. Bonwick and a "brain-storming group" as had previously been discussed. Mr. Bonwick responded: "My preference would be just me for an initial introduction and to develop some identified options or strategies. I would like to take that information away and include it in an agenda for a larger working group."

6.2 Paul Bonwick Hosts PowerStream and Others at the Heritage Dinner

562. Meanwhile, in February 2012, Mr. Bonwick began discussing the possibility of Collus and PowerStream attending the Heritage Dinner. In an email to Mr. Bentz, Mr. Houghton and Mr. Glicksman, Mr. Bonwick described the Heritage dinner as "that most significant Gala for the Liberals each year and will provide exceptional networking and communication opportunities."

563. On March 1, 2012, Paul Bonwick sent Ed Houghton a draft memo, asking him to "review and edit accordingly." The memo, which was from Paul Bonwick to Brian Bentz and Ed Houghton, included the following:

I would like to host a Table at the Premier's Annual Gala, the Heritage Dinner taking place March 21, 2012 at the Metro Convention Center. As part of hosting this Table I would be pleased to pick up the cost.

Invited guests would include, Brian Bentz Pres. CEO, Ed Houghton Pres. CEO, Mayor Cooper, Mayor Lehman, Mayor Bevilaqua, Mayor Scarpitti, Deputy Chief of Staff to the Premier Dave Gene, Executive Directive Liberal Party of Canada Ian McKay, County Warden & Mayor Cal Patterson and Paul Bonwick, Host.

I believe this would provide an invaluable networking opportunity for the individual guests to promote their municipal interests as well as that of our collective initiatives, both Collus/Powerstream and Powerstream. The attendees for the evening will include all of Cabinet, Senior Political Staff, Premier, elected officials from across the Province (for all levels of government) as well as Fortune 100 Execs. The event typically hosts approximately 2,300 guests.

I have a table on hold at this time as well as confirmation from Dave Gene and Ian McKay. Dave will make arrangements for the Premier to join us at the Table for a visit and I will arrange for the Minister of Energy to join us for the same. If the guests would like a visit from any other Minister I can arrange for that to take place. I can also assure you that our Table will be appropriately located for our benefit.

I appreciate discussion surrounding the financial part of the opportunity however I highly recommend that only private corporate dollars (mine) go towards a fundraiser of this magnitude.

He has asked that a meeting be scheduled in the next two weeks with the EVP Team as well as Ed and myself to develop strategic recommendations for the Premier's office as per their request.

On May 1, 2012, Mr. Bonwick responded to Ms. Sandino, retracting his request for a meeting, and advising that either he or Sarah Griffiths would "follow-up on a requested meeting in the very near future." Sarah Griffiths, Manager - Regulatory and Government Affairs at PowerStream, forwarded Mr. Bonwick's email to Mr. Glicksman and Colin Macdonald, commenting "I don't think this is an appropriate response to the Premier's Office..." Ms. Griffiths said that she would schedule a meeting as originally planned.

6.3 Additional Lobbying Involvement

569. On March 5, 2012 Brian Bentz was scheduled to meet Minister Bentley. Prior to the meeting, Paul Bonwick emailed Mr. Bentz and stated that, if Mr. Bentz were to suggest that the Minister encourage public comments regarding LDC consolidation, the suggestion would be well received. Mr. Bonwick also suggested that Mr. Bentz raise the

option of "specific tax incentives that would help stimulate activity" with the Minister. Mr. Bentz's administrative assistant sent a reminder to Mr. Bentz to call Mr. Bonwick before his meeting with the Minister.

6.4 Paul Bonwick Advises Ed Houghton on Responding to a Concerned Collingwood Citizen

571. A Collingwood resident wrote a letter to the editor of an unidentified newspaper questioning the sale of the shares in Collus. On March 14, 2012, Pam Hogg scanned a copy of the letter and sent it to Ed Houghton with the comment "What an idiot she is." Mr. Houghton forwarded the letter to Paul Bonwick, who shared it with Deputy Mayor Lloyd. Mr. Houghton wrote "She has finally surfaced!". Deputy Mayor Lloyd wrote "Its a

fucking joke!!! I wouldn't even give it a second thought. She have no credibility" Mr. Bonwick replied to Deputy Mayor Lloyd:

I was going to have a letter prepared that properly identifies her for what she is....constant critic, always negative, nothing but criticism...not to mention the premise of her letter is completely wrong!

In effect, mock the heck out of her and to some extent the paper for providing her a vehicle to promote negativity on a consistent basis allowing some type of credibility to a source that offers no credibility.

572. Mr. Bonwick sent a draft response letter to Mr. Houghton. Mr. Bonwick asked Mr. Houghton what he thought, "about someone from the public sending this letter to the editor."

...a wonderful announcement about our new partner PowerStream. It was my thinking that this would send a very positive message to the community about the quality of partner we have chosen.

6.5 Collus and Collingwood's 2011 Financial Statements: Sources of Information to Town Council About the Transaction

574. The Town of Collingwood's Financial Statements for 2011 fiscal year were prepared and audited after the share purchase agreement (SPA) was signed and before the transaction was closed on July 31, 2012. The 2011 Financial Statements reported on the Collus – PowerStream transaction as follows:

On March 6, 2012, the municipality, Collingwood Utility Services Corp. ("the Company"), COLLUS Power Corp. ("Power"), COLLUS Solutions Corp. ("Solutions") and COLLUS Energy Corp. ("Energy") entered into an agreement with PowerStream Inc. for the sale of 50% of the outstanding common shares of the Company held by the municipality. The company is the sole shareholder of Power, Solutions and Energy.

As part of this agreement, Power will be required to declare recapitalization and closing dividends to the company prior to the finalization of the agreement, with payments occurring following the closing date. Power has the ability to repay the promissory note to the municipality at its discretion. To the extent that the note is not repaid, the interest rate on the note will remain 7.25% in 2012 and will be reduced to 5.58% per annum in 2013. Following 2013, the interest rate on the note shall be determined based on Ontario Energy Board ("OEB") regulations.

Further, Solutions will be required to declare closing dividends to the company prior to the finalization of the agreement, with payments occurring following the closing date. Following receipt of the above dividends, the company will be required to declare the dividends to the municipality. The effect of this transaction will be a reduction in the investment in Government business enterprises and an increase in current assets. As well, in future years the municipality will only be consolidating 50% of the operations the company into its financial statements. The sale transaction was approved by the OEB on July 12, 2012 and it is expected that the sale will close during fiscal 2012. The dividends to be declared and paid will be based on the financial position of Power and Solutions at the closing date.

575. Meanwhile, Collus Power's auditor's notes for the 2011 year-end audit were prepared on March 28, 2012 and were reviewed by the audit partner on April 4, 2012. The audit notes described the impact of the upcoming share sale transaction as follows:

In fiscal 2011 the shareholder of the company's parent entered into a share purchase agreement for 50% of the parent company's shares. Within the sale agreement are clauses that would require Power to declare dividends upon the close of the deal to the parent company as well as take out long term debt to finance a recapitalization dividend that has the impact of reducing retained earnings of the company materially and adding a material amount of debt.

576. A set of financial statements for the Collus companies as at July 31, 2012, was prepared for the closing of the transaction. The Collus Power financial statements showed the long-term liabilities as a loan payable to Infrastructure Ontario in the amount of \$6.3 million, an earlier loan from Ontario Infrastructure Projects Corporation for 2.6 million and the outstanding note payable to the Town of Collingwood, which was described as, "7.25% note payable to the Town of Collingwood, no set terms of repayment."

577. As part of the 2011 year-end audit, CEO Ed Houghton and CFO Tim Fryer signed a management letter to the auditors confirming, among other things, that Collus Power Corp had disclosed the identity of the company's related parties, and all the related party relationships and transactions of which they were aware.

6.6 Council Considers the Collus Power Loan and Town Promissory Note

578. On April 12, 2012, Collingwood Council met *in camera*. The minutes from this meeting state, amongst other things, that, "Ms. Marjory Leonard provided the various options available in regard to calling the COLLUS promissory note to finance the acquisition of 507 Tenth Line."

579. Later in the meeting, Council passed the following resolution:

THAT Council authorize not calling the promissory note held by Collus, and monies be allocated from the sewer reserve to offset the cost of the 507 Tenth Line property acquisition.

580. Previously, on September 12, 2011, Council had approved the purchase of the 507 Tenth Line property in Collingwood. A resolution was passed at that time to call the promissory note in order to finance the transaction. At the time of that decision, in an email exchange between Mr. Houghton and CFO Tim Fryer about the implications of the Town calling the promissory note, Mr. Fryer explained, amongst other things, that, "...the loss of the annual before PILs interest payment counters any benefit of cashing in the Prom note. And of course it can never be renewed once it is gone."

6.7 Council Discharges CAO Wingrove; Ed Houghton is Appointed as Acting CAO for the Town

S81. At the Town Council meeting held Monday, April 2, 2012, Council moved into closed session and discussed a performance review for the Town's CAO. Council had previously discussed, "the background and current Town process of evaluating the CAO's performance" at the December 5, 2011 Council meeting. The minutes from the December 5, 2011 meeting reflect that, "[i]t was suggested that such reviews be conducted annually and early in each calendar year." Specifically, the Corporation will pursue opportunities for the acquisition, merger or other business arrangements with local distribution companies within the CHEC Group of LDCs, and consider other opportunities for acquisition, merger or other business arrangements, upon the recommendations of the Management and the Board of the Corporation, and such proposals shall be reviewed and considered by each Shareholder, acting in good faith, in the best interests of the Corporation.

In accordance with Section 14.11 of the Shareholders Agreement, this is also to confirm that PowerStream and the Town of Collingwood agree that the Corporation shall have the first right to evaluate and or pursue such M&A opportunities that may arise with CHEC Group of LDCs, and that PowerStream will first consider pursing M&A activities with LDCs having less than 20,000 customers, and within a reasonable geographic proximity to Town of Collingwood through the Corporation, prior to pursuing such opportunities through PowerStream.

 - c. That the shared services agreements would be reviewed annually so that the costs of the services under the agreements could be revised. If the parties could not agree on a revised cost of services, the cost would increase by 3.5% of the previous year's costs;
 - d. That there would be a five-year term of the Service Agreements; and
 - e. If the parties were unable to determine the cost of services, the cost would be determined by an independent accounting firm.

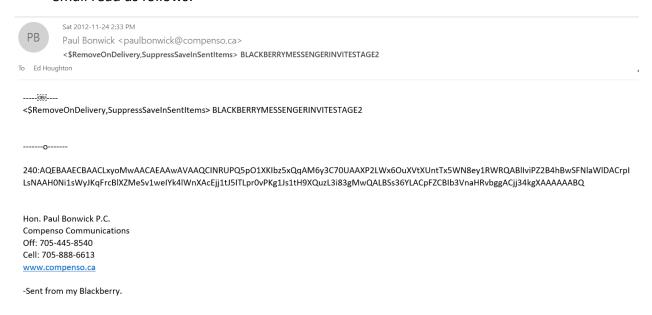
