Chapter 1: The Town of Collingwood: Roles Responsibilities and Relationships in 2012

Chapter 1 The Town of Collingwood: Roles, Responsibilities and Relationships in 2010

8. The Town of Collingwood was incorporated on January 1, 1858 and is located in Simcoe County on the shores of Georgian Bay. Between 1991 and 2011, Collingwood had a 33.8% increase in the size of its population, which was close to the average Ontario population increase during the same period. In 2016, Collingwood had a population of 20,102.

1.1 The Town Council and the Municipal Act

- 9. The Town of Collingwood is governed by an elected council, with elections held every four years.
- 10. The events that are the subject of this inquiry happened during the 2010-2014 council term. On October 25, 2010, a council election was held. Sandra Cooper was elected Mayor of the Town of Collingwood. Rick Lloyd was elected Deputy Mayor.

11. The roles and responsibilities of Ontario's municipal councils, heads of council, local boards and municipal employees are set out in the *Municipal Act*. This legislation applied to the councillors of Collingwood.

- 12. During the events that are the subject of this inquiry, Collingwood councillors were also bound by the *Municipal Conflict of Interest Act*. Under the *Municipal Conflict of Interest Act*, members of a municipal council were considered to have an indirect pecuniary interest in a given matter that came before Council if they:
 - a. "[were] a shareholder in, or a director or senior officer of, a [private corporation]...that [had] a pecuniary interest in the matter";
 - b. "[had] a controlling interest in or [were] a director or senior officer of, a [public corporation] ...that [had] a pecuniary interest in the matter";
 - c. "[were] a member of a body that [had] a pecuniary interest in the matter" or;
 - d. "[were] the partner of a person or...in the employment of a person that [had] a pecuniary interest in the matter"

13. Further, for the purposes of the *Municipal Conflict of Interest Act,* "the pecuniary interest, direct or indirect, of a parent or the spouse or any child of the member [was], if known to the member...deemed to be also the pecuniary interest of the member."

- 14. Councillors that had a direct or indirect pecuniary interest in a matter as defined by the *Municipal Conflict of Interest Act* were required by the *Act* to:
 - a. Disclose their interest in the matter before the matter was considered by Council;
 - b. Not take part in any discussions, votes or questions regarding the matter; and
 - c. Not attempt to influence councillors' votes on the matter before, during or after relevant meetings.

15. If a matter was being considered at a closed meeting, the *Municipal Conflict of Interest*Act also required councillors with a pecuniary interest to leave the room for the part of the meeting during which the matter was discussed.

16. These requirements did not apply to any pecuniary interest that a councillor had "by reason only of the member being a director or senior officer of a corporation incorporated for the purpose of carrying on business for and on behalf of the municipality or local board or by reason only of the member being a member of a board, commission, or other body as an appointee of a council or local board."

17. The senior administrator responsible for municipal services and staff is known as the Chief Administrative Officer or "CAO." At the start of the 2010-2014 term of council, the CAO for the Town of Collingwood was Kim Wingrove. Ms. Wingrove reported to Council through the Office of the Mayor, Sandra Cooper.

18. On November 25 and 26, 2010, Council received an orientation session from CAO Kim Wingrove. The presentation covered various health and safety matters, building security, municipal facilities and emergency procedures. Council members were advised that they had no expectation of privacy in the use of Town communications systems as these were part of the business records of the Town of Collingwood and were subject to inspection, review or disclosure without prior notice, for any business purpose or as required by law.

19. On January 6 and 7, 2011, a second Council orientation session was held at Collingwood Town Hall. John Mascarin and Leo Longo of the law firm Aird & Berlis gave slide presentations on municipal Law, defamation, and the *Municipal Conflict of Interest Act*.

20. The Town had a procurement policy in the form of By-law 2006-42. The By-law provided procedures for the Town for: establishing price ranges for purchases, tenders, quotes, establishing inventories, executing purchases, determining levels of approval for purchases, procurement or appointment of professional services and disposal of surplus goods.

21. Under the Municipal Act, a municipal Clerk is responsible for keeping records of meetings, votes, minutes, by-laws and related records. The agendas, materials and minutes of Council meetings are to be made public, unless they fall under the exceptions in the Municipal Act. Sara Almas, the current Clerk for the Town of Collingwood, held the position of Clerk during the 2010-2014 council term. Ms. Almas is not a lawyer.

22. In 2010, the *Municipal Act* had provisions that permitted municipalities to establish Codes of Conduct for Councillors, and to appoint an Integrity Commissioner to conduct inquiries into breaches of those Codes of Conduct.

23. On April 27, 2009, Clerk Sara Almas brought a staff report to Council recommending that it establish an *ad hoc* committee to review the Collingwood Councillor Code of Ethics and consider replacing it with a Code of Conduct. Council voted to accept the Clerk's recommendation.

24. In 2010, the Town of Collingwood did not have a Code of Conduct or an Integrity Commissioner.

1.2 The Town of Collingwood Code of Ethics for Members of Council

25. On May 15, 2006, Collingwood Council approved a Code of Ethics for Members of Council. The Code of Ethics was in place during the 2010-2014 Collingwood Council term and stated: "...this document will provide a guideline for elected officials in exercising their *policy making* role having regard to the statements and ideals enunciated hereunder" [emphasis in original]. The Code included provisions regarding confidential information, treatment of staff, gifts, use of Town property, transparency, and roles.

26. The Preamble to the Code of Ethics began by stating that "[a]ttaining an elected position within one's community is a privilege which carries significant responsibilities and obligations." The Preamble also stated that members of Council should carry out their duties in a "fair, impartial, transparent and professional manner."

27. Following the preamble, the Code of Ethics provided that:

The Town of Collingwood's Members of Council fundamentally understand that;

- a. the proper operation of democratic and representative municipal government requires that they be independent, impartial and responsible to the people,
- b. there are open and proper channels for decision making and approval of policy,
- c. conflicts between the private interests of elected representatives and their public responsibilities represent an ethical challenge to maintaining an open, accountable and transparent process;
- d. as leaders of the community, they are held to a higher standard of behaviour and conduct.

28. The version of the Code of Ethics in place during the 2010 – 2014 Council term prohibited members from accepting any gift that could be construed as having been given to a member of Council in exchange for special treatment. Members were also not to accept gifts with a value higher than \$500 without approval from Council, nor to accept gifts related to accommodation and transportation with a value over \$200. The Code of Ethics that was in place during the 2010-2014 Council term did not address lobbying activity.

29. All members of the Council of 2010-2014 signed the Code of Ethics on December 6, 2010. The signature lines appeared under the following statement:

Council of the Corporation of the Town of Collingwood have read the information attached hereto in its entirety and hereby acknowledge and accept the Code of Ethics for Members of Council.

- 1.3 The Mayor of Collingwood, Sandra Cooper, and Paul Bonwick
- 30. Sandra Cooper was the Mayor of Collingwood for the 2010 2014 term.

31. During the 2010 election, Mayor Sandra Cooper campaigned in part on a platform of reducing the Town's spending and decreasing its debt. Prior to her election as Mayor,

Sandra Cooper served as a Councillor (from 1997-2003), and then Deputy Mayor (from 2003-2010). Mayor Cooper's brother, Paul Bonwick, was a member of Council from 1994 to 1997. He also served as a member of the parliament of Canada from 1997 until 2004.

32. In an email which he addressed to his "Little Sister," Paul Bonwick helped Mayor Cooper write her inaugural speech.

33. Mr. Bonwick also provided Mayor Cooper advice early in her term to help her "build support" and on how she could "look good." Examples of his advice are set out in the next three paragraphs.

34. On February 25, 2011 Mr. Bonwick wrote an email on the subject, "Bulldog" to Mayor Cooper as follows: "cut cut cut...strong leadership." Mayor Cooper responded to her brother's message with thanks.

35. On March 3, during a budget meeting, Mr. Bonwick wrote to advise Mayor Cooper to "push hard woman...1% reduction and you will be a hero...do not take no for an answer...make a clear and hard statement."

- 36. In the lead-up to Council budget deliberations in 2011, Mr. Bonwick suggested to Mayor Cooper that cutting spending would show strong leadership on her part. His email set out the following "[i]deas":
 - Eliminate several positions in by-law department
 - Cut the Economic Development Budget by 250K
 - Cut Museum budget by 150K
 - Tell CAO you want a 1% reduction!
 - Differ capital projects if possible.

Mr. Bonwick also provided Mayor Cooper with draft remarks for the budget meeting. The remarks included praise for budget Chair and Deputy Mayor Rick Lloyd, and the following statement: "[o]ur Commercial and Industrial businesses have struggled to simply survive, if ever the time is now to offer a helping hand." The draft remarks concluded as follows:

Let's send a message that we are open for business and sympathetic to the difficult time many people in our community are facing. I for one want to see our staff go back to the drawing board and present this Council with a reduction in spending. Not more and not status goe!

37. In 2010, Paul Bonwick and his company, Compenso Communications Inc. ("Compenso"), were in the business of government relations. Mr. Bonwick was a registered lobbyist.

- 1.4 The Deputy Mayor of Collingwood, Rick Lloyd, and Paul Bonwick
- 38. Rick Lloyd was the Deputy Mayor of Collingwood for the 2010 2014 Council term.

39. Paul Bonwick and Deputy Mayor Lloyd were former business associates. They worked together from 2008 to 2009 in a gravel pit business (Blue Mountain Aggregates, formerly Eden Oak) purchased by Mr. Bonwick. Deputy Mayor Lloyd worked in the day-to-day operation of the gravel pit. Several Lloyd family members were on the payroll of Mr. Bonwick's company, Compenso, during the period of 2008-2009.

40. By the start of the 2010 council term, Mr. Bonwick was being sued by Di Poce Management Ltd., and was the subject of bankruptcy proceedings which continued until 2013. On April 3, 2011, Mr. Bonwick introduced Deputy Mayor Lloyd to his lawyer as the former Director of Operations for Blue Mountain Aggregates and as a potential candidate to swear an affidavit. Deputy Mayor Lloyd was copied on that email. All matters in the litigation were settled in 2013.

1.5 Councillor Ian Chadwick, Paul Bonwick, and Compenso Communications

41. Ian Chadwick was a member of Council for the 2010 – 2014 term.

42. Councillor Chadwick provided services to Paul Bonwick's company, Compenso, during the 2010-2014 term of Council. In April of 2011, Compenso paid Councillor Chadwick \$2625 for services provided. Starting in July of 2011, Councillor Chadwick provided Compenso with monthly research services and summaries of news about the electricity sector. Compenso paid Councillor Chadwick \$700.00 per month for this work. At times, Mr. Chadwick provided other services for Compenso, for which Compenso paid him additional fees. These activities are described in greater detail in Summary Document 1-5

43. Various unsigned independent contractor agreements between Councillor Chadwick and Compenso contemplated a one-year contract in which Councillor Chadwick would provide services to Compenso at a rate of \$37.50 per hour. The term in the agreement was between March 1, 2011 and March 1, 2012. In one iteration of the agreement, Mr. Chadwick was required to communicate only with Mr. Bonwick for all matters related to the agreement whereas, in other versions, Mr. Chadwick was to communicate with another specific individual. Some versions of the agreement required Mr. Chadwick to complete his work in Compenso's offices, while others permitted Mr. Chadwick to carry out his work at home.

44. As discussed in more detail below in section 7.12 and in Summary Document 1-5,
Councillor Chadwick worked for Paul Bonwick and Compenso for the period between
August 2011 and December 2013. Compenso paid Councillor Chadwick a total of \$24,475
for his work. Compenso's last payment to Councillor Chadwick was on December 23,
2013.

1.6 Collingwood Electricity Distribution: Structure and Relationships 2000-2010

- 45. Before the share sale of 2012, which is a subject of this inquiry, the Town of Collingwood was the sole shareholder of Collus (the Collingwood Utilities Services Corporation, also referred to as COLLUS). Collus was a holding company. It owned three subsidiary companies:
 - a. Collus Power: a licensed electricity distribution company known as an LDC or local distribution company. Collus Power was regulated by the Ontario Energy Board;

 - c. Collus Energy: an inactive corporation.

46. Collus, and each of its subsidiary companies had a Board of Directors. Each of those Boards included Council representatives.

47. In June 2006, Collus implemented a policy to regulate the company's purchase of goods and services. Under the policy, the purchase price for goods or services were to be determined as follows:

Up to \$1,500 - For any purchases other than those items contained in a Standing Purchase Order, when the amount is less than \$1,500, the Buyer making the purchase shall obtain verbal quotations from more than one supplier, or, they may purchase directly from catalogues, suppliers' lists or through negotiations, upon assuring themselves that all prices offered are fair and equitable;

\$1,500 to \$50,000 - For all purchases, when the amount is between \$1,500 and \$50,000, an Inquiry for written Quotation shall be issued on Prescribed Forms;

[O]ver \$50,000 - By Tender on Prescribed Forms;

48. Further, purchases made by Collus were subject to approval requirements that varied based on the value of a given purchase:

[U]p to \$ 5,000 - By any Buyer or Department Head;

[U]p to \$25,000 - By any Department Head; and

[O]ver \$25,000 - By Department Head and the Chief Executive Officer or Chief Financial Officer as evidenced by the passing the current years budget."

49. The policy also described the procedures by which purchases, tendering and the procurement of professional services were to be carried out.

1.7 History of the Collus Companies

50. The *Electricity Act*, passed by the Ontario Legislature in 1999, required local public electric utilities to be constituted as business corporations under the *Ontario Business Corporations Act*. In 1999, the Collingwood Public Utilities Commission received advice during its corporate transition from accounting firm KPMG (Klynveld Peat Marwick Goerdeler) partners John Herhalt and Jonathan Erling, and from the law firm Power Budd. Mr. Herhalt, Mr. Erling and Peter Budd presented at a strategic planning session for the Collingwood Public Utilities Commission in 1999. On March 27, 2000, the Town passed a by-law approving the incorporation of Collus and its subsidiary companies: Collus Power, Collus Solutions and Collus Energy.

51. Collus was a member of the Cornerstone Hydro Electric Concepts Association group (CHEC), a group of 12 utilities that shared resources.

52. The CPUSB was created by by-law on February 16, 2004. Relevant services agreements were amended on November 4, 2004 to correspond to the new name for the Public Utilities Commission, the CPUSB.

1.8 The Town of Collingwood's Shareholder Direction to Collus

53. When the Collus companies were created in 2000, Council passed a Shareholder Direction to govern the relationships between the Town and the Collus companies. The Shareholder Direction, amongst other things, recognized the primacy of the Ontario Energy Board, or the "Regulator", on matters of decision-making and policy. The Shareholder Direction provided, amongst other things, that,

The Shareholder's objective in its relationship with the Corporation and the Electricity Business is that the Board supervise the management of the business and affairs of the Corporation in a manner that:

- (a) ensures that the value of the Corporation and the Subsidiaries is maintained or increased;
- (b) protects the investment of the Shareholder by managing the exposure of the Corporation to risks inherent to the Electricity Business through the development of a strategic planning process and risk management strategy;
- (c) provides the Shareholder with its desired rate of return on its investment as permitted by the OEB;
- (d) provides adequate reporting to the Shareholder;
- (e) establishes and maintains appropriate financial and capital structures for the Corporation and the Subsidiaries giving due consideration to the rate of return permitted by the OEB; and
- (f) provides energy services in an environmentally responsible manner.

54.  - (b) An operating and capital expenditure budget for the next fiscal year and an operating and capital expenditure projection for each of the two fiscal years thereafter, including the resources necessary to implement the draft business plan;
 - (c) Pro forma consolidated Financial Statements for each fiscal year, including projected dividend payments to the Shareholder;
 - (d) An acquisition budget setting forth the nature and type of capital expenditures proposed to be made in the following fiscal year, supported by explanations, notes and information upon which the budget was based;
 - (e) Energy conservation programs and environmental plans;
 - (f) Any material variances in the projected ability of any business activity to meet or continue to meet the financial objectives of the Shareholder; and
 - (g) Any material variances from the Business Plan then in effect.

1.9 The Collus/CPUSB/Town Service Agreements

- 56. A series of service agreements governed the arrangements between Collus, Collus Power, Collus Solutions, the CPUSB, and the Town. These services included:
 - a. Combined billing for power, water and wastewater charges;
 - The Town providing space to Collus, for which it received annual rental payments;
 and
 - c. Collus Solutions providing information technology (IT) services to the Collus entities, the Town and the CPUSB. Collus charged the Town for these services.

In addition to these services, work done by Collus employees on Town matters was shown on Collus's financial reports and statements as "in kind" benefits (dividends) to the Town.

1.10 The Promissory Note to the Town and Collus' Financial Objectives in 2010

57. On June 10, 2002, Collus Power issued a promissory note to the Town. The promissory note provided that Collus Power would pay the Town \$1,710,169.00 at the Town's demand. Collus made annual interest payments on the note to the Town at an interest rate of 7.25%. The promissory note was still in place at the time of the 2010 council election.

- (b) Ensure ongoing access to funding to maintain and improve the electricity distribution system and to ensure that capital needs are met.
- (c) Ensure compliance with covenants related to its credit facilities and the Town of Collingwood promissory note.
- (d) Ensure that the capital structure is such that the debt to equity structure deemed by the OEB is not exceeded.

1.11 Ed Houghton: Dual Roles with Collus and the Town of Collingwood

59. In 2010, Ed Houghton was the President and CEO for Collus and its three subsidiaries, and the Executive Director of Engineering and Public Works for the Town of Collingwood.

60. In his role as President and CEO of Collus and its subsidiaries, Ed Houghton reported to the Boards of Directors of those corporations. The Collus and Collus Power Boards were chaired by Dean Muncaster, who also chaired the Board of the CPUSB. The Collus Solutions Board was chaired by Joan Pajunen, and the Collus Energy Board was chaired by Doug Garbutt. All electricity and water employees reported to Ed Houghton through the Director of Operations and IT services, Larry Irwin. Collus Solutions paid the salaries of Mr. Houghton and Mr. Irwin.

Town staff who reported to Mr. Houghton as Director of Engineering and Public Works included the Manager of Public Works, the Manager of Engineering, and an Administrative Assistant. The Director of Engineering and Public Works position description in 2010 required the holder of the position to be a professional engineer, with a P. Eng. designation. Mr. Houghton held a diploma from Fanshawe College in civil engineering technology.

1.15 The Report of the Ontario Distribution Sector Review Panel

104. In April 2012, the Ontario Minister of Energy established the Ontario Distribution Sector Review Panel to provide expert advice to the government on how to improve efficiencies in the electricity sector, with the aim of reducing the financial cost of electricity distribution for consumers. Collus director David McFadden was a member of the Panel. The Panel published a report in December 2012.

105. The report reviewed the history and current state of Ontario's electricity sector and concluded that "most municipalities and LDCs understand the status quo will not serve the citizens of the province well in the decades to come." The report's primary recommendation was that 73 of Ontario's Local Electricity Distribution Companies (LDCs) be consolidated into "8 to 12 larger regional distributors that are large enough to deliver improved efficiency and enhanced customer focus, while at the same time maintaining a strong connection with their local communities."
