BLT Construction has a substantial and direct interest in the subject matter of the Inquiry in Phase II. This application was deliberately not brought in Phase I, though Phase I was monitored by BLT. Having now monitored Phase I, its participants, and the evidence called, it has now become clear to Counsel that BLT's full participation will be of assistance to the Inquiry and an application for standing should be made. BLT built the Sprung structure recreational facilities that will be the subject of discussion during Phase II. The Principals of BLT are anticipated witnesses in Phase II who will be able to provide background and invaluable insight into how the construction contract was awarded and the work involved in its implementation. BLT being granted full participation rights will advance the goals of the Inquiry and contribute to the openness, fairness and thoroughness of the Inquiry.
